40 CFR Part 63 Subpart ZZZZ Applicability

Dear Mr. Arif:

Seminole Energy, LLC is submitting this document to the Florida Department of Environmental Protection (FDEP) Division of Air Resource Management (DARM) to provide the regulatory agency with information on the:

1. Date that construction commence for its landfill gas electricity generation facility that is operated at the Osceola Road Solid Waste Management Facility; and
2. Applicability of 40 CFR Part 63 Subpart ZZZZ (Subpart ZZZZ).

40 CFR Part 60.4230 specifies that ... *the date that construction commences is the date the engine is ordered by the owner or operator.*

40 CFR Part 63.6590 specifies that *An affected source is any existing ... stationary RICE located at a ... area source.*

40 CFR Part 63.6590 specifies that *For stationary RICE located at an area source of HAP emissions, a stationary RICE is existing if you commenced construction ... before June 12, 2006.*

40 CFR Part 63.6590 specifies that ... *an existing stationary RICE that combusts landfill gas ... equivalent to 10 percent or more of the gross heat input on an annual basis, does not have to meet the requirements of this subpart and of subpart A of this part. No initial notification is necessary.*

Seminole Energy, LLC placed an order on December 19, 2005 for the four (4) landfill gas fueled CAT G3520C IC engines that have been installed at the Osceola Road Solid Waste Management Facility. Attached is a copy of the original purchase order submitted to the equipment dealer for these engines.


