On January 21, 2000, C. F. Industries applied to the Dept. of Environmental Protection for an air construction permit and submitted the appropriate fee of \$7,500 in two checks, one for \$5,000 and the other for \$2,500. The application was determined to be initially incomplete, and the company was notified by certified mail February 17, 2000. Neither C. F. Industries nor its representatives responded to the request for information, and the Department recently contacted the company to see if they wished to pursue this project. The company decided at that time to withdraw the application. Since the Department did not do enough work on this application to consider the fee earned, we are requesting the company be refunded the \$7,500 fee requested on the two Application for Refund forms.
