FINAL PERMIT DETERMINATION

I. COMMENTS

The Public Notice of Intent was published in the Tampa Tribune on May 25, 2005. No public comments were received during the 14-day public comment period which ended on June 8, 2004. The following comments were received from the applicant on May 31, 2005. Department response follows each comment.

A. The Environmental Protection Commission of Hillsborough County, the compliance authority for this permit, has recently moved to a new address: 3629 Queen Palm Drive, Tampa, Florida, 33619. The new address should be entered in Section II Condition 2 of the permit.

Response: This update has been made.

B. Section III of the permit should include revisions to the conditions of Construction Permit No. 0570005-006-AC regarding the Acid Clean-up Unit.

Response: These revisions have been included.
