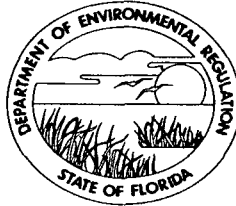

Dear Mr. Williams:

This office is in receipt of applications to modify TECO-Gannon Plant, Units 1-4 to coal fired units. I am aware that during the rule-making proceedings setting emission limiting standards for these units that considerable discussion took place regarding the procedure to verify compliance with the emission limitations.

Please submit information containing a proposal from TECO on how compliance can be assured. This should include coal sampling methods and frequency, continuous instack monitoring equipment, notification procedures, etc. The assurance program should be something TECO can comply with and at the same time provide the Department with assurance emission limiting standards are being complied with.

Further processing of your applications will be held in abeyance pending resolution of the details of the compliance assurance program.

Enclosed please find four (4) originals with four (4) copies each of Construction Permit Applications for the subject units.

Also, enclosed please find a Certificate of Good Standing and an authorization letter for the applicant. The applications, together with a check for \$200.00 to the Hillsborough County Board of County Commissioners and a check for \$80.00 to the Florida Department of Environmental Regulation, are included with Mr. Stewart's copy.

The applications have been designated to be for Construction Permits. While the boilers will be modified (converted) to burn coal, there will be major construction required for the addition of electrostatic precipitators.

The data and emission rates presented in the application relate to the revision to Florida's State Air Implementation Plan which was adopted by the Florida Environmental Regulation Commission on October 23, 1980. Specifically, the revision is in Florida Administrative Code, Chapter 17-2.05 (6), Table II, E., Emission Limiting Standards - Fossil Fuel Steam Generators, encompassing units 1 through 6 at Francis J. Gannon Station of Tampa Electric Company.
