1. Paragraphs 26, and 27 and 28 of the consent decree are the specific requirements related to Gannon and repowering of the Bayside Facility. TEC believes these requirements have been satisfied as shown attached. Therefore, we request that the consent decree reference be deleted from the permit similar to the Bend Title V permit (-060AC and -061AV).
2. We would like to retain the emissions point sources in the Title permit as shown below. Even though none of these activities exist, we would like to preserve our right to utilize these activities in the future, if necessary. The current plan is to utilize a manual water suppression system (as necessary) to control fugitive emissions. TEC believes this approach provides reasonable assurance of meeting the 20% opacity requirement in the permit.
