- 1. An updated Phase II Acid Rain Part Application was omitted. Please be advised that Department Rule 62-214.320(1)(i) requires that, "the designated representative of any Title V source having a Title V permit with an Acid Rain Part shall submit a complete application for renewal of the Title V permit with the Acid Rain Part for each Acid Rain unit at the source." Since the application is lacking, please write in "Renewal" for the action sought. (Also, please check if there are any changes to the Designated Representative for the facility, and submit an updated Certificate of Representation if necessary.)
- 2. Please try to establish the CAM Plan in a tabular form, so that we can refer to it in the Title V Permit as an attachment.
