MOTION TO WITHDRAW REQUEST FOR EXTENSION OF TIME FOR FILING PETITION FOR FORMAL ADMINISTRATIVE HEARING

Petitioner, Orlando Utilities Commission ("OUC"), by and through its undersigned counsel, hereby moves to withdraw its Request for Extension of Time for Filing Petition for Formal Administrative Hearing with the Florida Department of Environmental Protection ("Department") in the above-described permitting matter and states:

- 1. OUC submitted an application on March 6, 2008, to the Department for a Prevention of Significant Deterioration ("PSD") Permit for revision of the combined-cycle portion of the previously permitted integrated coal gasification and combined-cycle ("IGCC") unit (Unit B) at the Curtis H. Stanton Energy Center ("Stanton Energy Center") in Orange County, Florida.
- 2. On March 25, 2008, the Department issued its Written Notice of Intent to Issue PSD Permit to OUC for construction of a natural gas-fueled, combined-cycle unit (Unit B Modification) at the Stanton Energy Center. Applicant, OUC, received the Written Notice of

Intent on March 25, 2008 via electronic mail. OUC published the required Public Notice in the Orlando Sentinal on April 2, 2008.

- 3. Pursuant to applicable statute and rules, the Department accepted written comments concerning the proposed draft PSD Permit through May 2, 2008, which is thirty (30) days from the date OUC published the required Public Notice.
- 4. There have been no written comments received during the thirty (30) day period since OUC published the Public Notice. OUC therefore withdraws its Request for Extension of Time for Filing Petition for Formal Administrative Hearing and requests that the Department issue its PSD Permit to OUC.

Accordingly, OUC respectfully requests that the Department grant OUC's Motion to Withdraw.
