Thank you for your recent submission of the subject Title V permit revision application. However, we must deem your application *incomplete* due to the following concerns:

- The required Statement of Compliance was not included.
- If warranted, a Compliance Plan and Schedule must be included for any units not in compliance.
- Specific Conditions 11. and 12. in the most recent Air Construction Permit (0970014-003-AC) require manufacturers' emissions performance versus load diagrams for the specific dry low-NOx system and water injection system as part of the Title V permit revision application. Please provide these diagrams, since they were not included in the application.
- Please provide historic facts and data to justify the request to change the existing excess emissions language in the permit "to allow up to two hours of excess emissions for each startup and shutdown cycle" for combustion turbines P7 through P14.

When we receive your response to the above items, we will continue the processing of the permit revision application.
