Dear Mr. Smith:

The Florida Department of Environmental Protection has reviewed your application for a renewal of the Title V Air Operation Permit for the Riviera Plant. However, we must deem your application *incomplete*, because we need further information relative to the following items:

1. Subsequent to their review of the Title V permit renewal application submitted for the Riviera Beach Generating Station, the Palm Beach County Health Department has provided the following information relative to the plant emissions:

Using the current MET data (2001-05), the concentrations exceed sulfur dioxide (SO₂) National Ambient Air Quality Standards (NAAQS) (see below).


Pursuant to Rule 62-204.220(1), Florida Administrative Code (F.A.C.), the Department may not issue an air permit to a facility that causes or contributes to a violation of an ambient air quality standard. Based on the above preliminary results that indicate modeled violations of the ambient air quality standards, additional modeling and a possible reduction of the allowable SO₂ emissions rate will be required before we can issue this permit. Please do the analysis to model this situation, and provide an assessment with a recommended plan of action. In your response, please provide all of the required input data necessary (i.e. property boundaries, building sizes

and orientations, stack parameters, etc.) to conclusively determine the full extent of the impact that the allowable emissions from this facility have on the ambient air quality standards contained in rule 62-204.240, F.A.C.

2. Please provide an assessment as to the applicability of the following federal regulations with regard to the emergency generators at the plant:
 - 40 CFR 60, Subpart IIII—Standards of Performance for Stationary Compression Ignition Internal Combustion Engines.
 - 40 CFR 60, Subpart JJJ—Standards of Performance for Stationary Spark Ignition Internal Combustion Engines.
 - 40 CFR 63, Subpart ZZZZ—National Emissions Standards for Hazardous Air Pollutants for Stationary Reciprocating Internal Combustion Engines.

When we receive this information, we will continue processing your application. If you have any questions, please contact Project Engineer Tom Cascio at 850-921-9526. Rule 62-4.050(3), F.A.C., requires that all applications for a Department permit must be certified by a professional engineer registered in the State of Florida. This requirement also applies to responses to Department requests for additional information of an engineering nature. Permit applicants are advised that Rule 62-4.055(1), F.A.C., requires applicants to respond to requests for information within 90 days, unless the applicant has requested in writing, and has been granted, additional time within 90 days.
