

Request to Decommission Non-Performing Gas Collection Wells

Dear Mr. Santos:

CDM, acting on behalf of the Solid Waste Authority of Palm Beach County (SWA), is in receipt of your letter dated February 28, 2003, regarding our request for decommissioning of certain landfill gas (LFG) system collection wells at SWA Class I Landfill.

In our letter dated January 23, 2003, we requested that certain LFG wells be decommissioned if they met all four of the following criteria:

- Location in an area of non-degradable waste;
- Low, or no flow;
- Low, or no concentration of methane;
- These conditions are due to lack of gas being generated in the area, rather than to a condition of screen clogging or leakage, which can be repaired.

You pointed out in your February 28th letter that many wells in the Class I Landfill exhibit one or more of these criteria. It is SWA's intent, at this time, to request that only Wells 25, 31, 38 and 51 be disconnected from the collection system, because they currently meet all four of these criteria. SWA would like to exempt these four wells currently, as well as develop a process under which other wells that meet these four criteria could be decommissioned in the future.

SWA has recently begun a program of repair, reconstruction, and expansion of the Class I Landfill gas collection system. The program is aimed at increasing the efficiency of the system, eliminating many of the system deficiencies (such as low flow in some of the wells), and expanding the system into the newest areas of the landfill. During this program, all wells will be evaluated and repairs made where necessary.

SWA believes that Wells 25, 31, 38, and 51 are in areas containing almost entirely ash, and cannot be made to be productive, because little or no gas is being generated in their vicinity. You stated in your February 28th letter that: "Pursuant to 40 CFR 60.759(a)(3)(ii) 'any nonproductive area of the landfill may be excluded from control provided that the total of excluded areas can be shown to contribute less than one percent of the total amount of NMOC emissions from the landfill.' SWA needs to provide a report that demonstrates that the above requirement is met."

SWA is committed to maintaining environmental compliance for its landfill gas collection system and will provide the report requested by the Department. SWA will conduct sampling of the landfill gas in each of these wells proposed to be decommissioned, and at the inlet to the flare, to determine NMOC concentrations in accordance with Method 25C. This information, along with information on the amount and age of degradable waste in the zone of influence of each well, and in the landfill as a whole, will be used in the LANDGEM model to determine if the total NMOC generation rate from the areas proposed to be excluded would contribute less than one percent of the Landfill's total NMOC generation rate. SWA will present this information in the report to the Department, as you have requested. SWA understands that these wells cannot be decommissioned until the Department has reviewed and approved this report, its methodology and its findings.
