### Dear Mr. Hammond:

The Department reviewed your request of February 2, 2009 to extend the expiration date of the above referenced construction permit from March 31, 2009 to March 31, 2010. The additional time will allow completion of construction of the Biosolids Pellitization Facility.

Per Rule 62-4.080(3), Florida Administrative Code (F.A.C.), an extension for a construction permit shall be granted if the applicant can demonstrate reasonable assurances that upon completion, the extended permit will comply with the standards and conditions required by applicable regulation.

We already have fairly extensive information about the facility and the control equipment. To complete the reasonable assurance requirement allowing extension of the permit, please submit the following information:

The Department needs to make a determination that there was not a delay of more than 18 months in either commencing construction or any break in construction activities for all the emission units that underwent modification. The determination can not be made from the contractor's construction schedule in Attachment B of your request. Please provide this documentation.

According to Rule 62-4.080(3), F.A.C. the permit will remain in effect until the Department takes final action. Permit applicants are advised that Rule 62-4.055(1), F.A.C. now requires
