Dear Mr. Hammond:

On August 9, 2010, the Department received your partial response to our request for addition information (RAI) dated June 16, 2010. On August 23, 2010 additional information was submitted to the Department; however, this did not constitute all of the outstanding information needed to the application review.

Upon receipt of the August 23 information, the permit review clock was reset, and this letter is to inform you that we are evaluating whether the application is complete. We understand that there will be another submittal that will, at a minimum, formalize the recent decision to reduce the nitrogen oxides (NO_X) proposal. We will, nevertheless, advise on or before September 22, 2010 whether we require additional information.

We have not yet received comments from U.S. EPA Region 4 or the U.S. National Park Service. These will be forwarded to you as soon as received. If you should have any questions, please contact me at 850/921-7744 (permit) or Melody Lovin (modeling) at 850/921-9537.
