The Department has received your responses to our RAI dated June 16, 2010 regarding Permit Application 0990234-017-AC (PSD-FL-413) on September 14, October 6 and October 12. The most recent information transmitted via Malcolm Pirnie is the Air Quality Monitoring Report for the 1-hour sulfur dioxide (SO₂) and nitrogen oxides (NO_X) ambient impact projections.

The Department will reset the 30-day review clock based on the receipt of the October 12 submittal.

We may receive comments from the U.S. EPA Region 4 (EPA) or the U.S. National Park Service (NPS) regarding the latest modeling submittals. These will be promptly forwarded along with our own review.
