Dear Ms. Vielhauer:

On behalf of Florida Power & Light Company (FPL) and its Designated Representative, Sheila M. Wilkinson, the West County Power Partners, LLC (WCPP), EPC Contractor for construction of the new combined cycle generating unit at the FPL West County Energy Center – Unit 1&2, is submitting this notification in accordance with the regulations cited below.

This correspondence is to serve as notification to the Department, in accordance with the Florida Statutes, Chapter 62-4 of the Florida Administrative Code [Design; Rule 62-4.070(3), F.A.C.]. Prior to performing a major tuning session, FPL is providing this notification of the DLN tuning of Combustion Turbines (CT) 1A, 1B, and C while firing natural gas. The proposed tuning schedule is detailed in Table 1.
