Dear Mr. Power:

On December 8, 2008, the Department received your request (copy enclosed) to extend the time in which to perform testing under the subject permit. The Title V air operation permit is for the Pasco County Resource Recovery Facility. The facility is located in Pasco County at 14230 Hays Road, Spring Hill.

We have reviewed the federal regulation provisions and concur that the facility is allowed to test within the 15 month window afforded by the May 10, 2006 federal amendments which were adopted into the state Rule 62-204.800(9)(b), Florida Administrative Code (F.A.C.), effective May 31, 2007. Also, completion of the 2009 year testing by September 30, 2009, as you have proposed ensures the federal fiscal year test requirement from Rule 62-297.310(7)(a)4., F.A.C. contained in the specific conditions of the permit are met.

Dear Mr. Sheplak:

The revised Municipal Waste Combustor (MWC) New Source Performance Standards, as published on May 10, 2006, (71 FR 27324) establishes testing flexibility for the annual compliance tests to be conducted once per calendar year, but no less than 9 months and no more than 15 months since the previous test (as long as 5 performance tests are conducted in each 5-year calendar period). This update to the Federal 40 CFR 60, Subpart Cb standards is a change from the previous 12-month testing frequency requirement.

The Department adopted these rule revisions in 62-204.800(9)(b) F.A.C. by reference, which became effective on May 31, 2007. Although the USEPA recently filed a motion to remand certain provisions of the amendments to 40 CFR 60, Subparts Cb and Eb, the amended provisions reflecting the new testing frequency remain in effect. Pasco County recently applied to the Department to incorporate these (and other) provisions into the facility's Title V Operating Permit.

The facility operator, Covanta Pasco, Inc., is in the process of scheduling the Fiscal Year 2008 Stack Test and would like to be able to utilize the flexibility afforded by the revisions. Therefore, Pasco County is requesting that the Department approve this testing frequency flexibility to allow the Pasco County Resource Recovery Facility annual compliance test be moved from January 2009 to March 2009 in accordance with the 15 month provision.
