NOTICE OF ADMINISTRATIVE PERMIT CORRECTION

Based on a request and information provided in a letter from Pasco County received December 22, 2000, the Department has determined that a minor correction to information contained in FINAL Permit Number 1010056-002-AV is required. The change adds a new specific condition to the Storage Silo for Activated Carbon section of the permit, and is necessary to allow testing of the silo when the maximum permitted rate is unachievable. The language is identical to that of Specific Condition A.51., that is part of the Municipal Waste Combustor section of the permit. This correction is minor in nature and does not alter, modify, or revise any permit requirement. This Administrative Permit Correction was processed as project number 1010056-003-AV, pursuant to Rule 62-210.360, F.A.C. The correction is as noted below.

- Specific Condition B.8.1. is added:

B.8.1. Operating Rate During Testing. Testing of emissions shall be conducted with the emissions unit operation at permitted capacity, which is defined as 90 to 100 percent of the maximum operation rate allowed by the permit. If it is impracticable to test at permitted capacity, an emissions unit may be tested at less than the minimum permitted capacity; in this case, subsequent emissions unit operation is limited to 110 percent of the test load until a new test is conducted. Once the emissions unit is so limited, operation at higher capacities is allowed for no more than 15 consecutive days for the purpose of additional compliance testing to regain the authority to operate at the permitted capacity.
[Rules 62-297.310(2) & (2)(b), F.A.C.]

This permit correction corrects and is a part of FINAL Permit Number 1010056-002-AV. This permit correction is issued pursuant to Chapter 403, Florida Statutes.

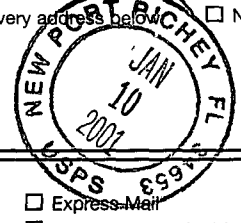

RE: Pasco County Resource Recovery Facility - Title V Permit

Dear Mr. Sheplak:

As discussed with Mr. Jason Gorrie of Camp Dresser & McKee Inc., on December 6, 2000, Pasco County requests an administrative change to Permit No. 1010056-002-AV (Title V Permit). Specifically, we request that the following limitation be added in Subsection "B" as it relates to the Activated Carbon Storage Silo (E.U. ID No. 004):

Operating Rate During Testing: Testing of emissions shall be conducted with the emissions unit operating as permitted capacity, which is defined as 90 to 100 percent of the maximum operation rate allowed by the permit. If it is impracticable to test at permitted capacity, an emissions unit may be tested at less than the minimum permitted capacity; in this case, subsequent emissions unit operation is limited to 110 percent of the test load until a new test is conducted. Once the emissions unit is so limited, operation at higher capacities is allowed for no more than 15 days for the purpose of additional compliance testing to regain the authority to operate at the permitted capacity. [Rules 62-297.310(2) and (2)(b), F.A.C.]

The above requested language is identical to that found at Specific Condition A.51 of the permit and is necessary to allow testing of the silo when the maximum permitted rate is unachievable.
