Air Construction Permit Modification and Title V Air Operation Permit Renewal

Dear Mr. Power:

On August 4, 2011, the Department received an air construction permit modification and a Title V air operation permit renewal for the existing Pasco County Resource Recovery Facility. The renewal application addresses new and existing reciprocating internal combustion engines (RICE) and streamlining permit conditions between previous prevention of significant deterioration (PSD) and Title V air operation permits.

The application is incomplete. In order to continue processing the application, the Department needs the additional information requested below. Should a response to any of the below items require new calculations, please submit the new calculations, assumptions, reference material and appropriate revised pages of the permit application form.

In the air construction permit and Title V permit renewal application:

1. Facility Regulatory Classifications

On page 12 Box 10: One or More Emissions Units Subject to NESHAP (40 CFR Parts 61 and 63).

Check if the facility addressed in this application has one or more emissions units subject to a standard promulgated by the U.S. Environmental Protection Agency (EPA) under section 112(d) of the Clean Air Act (40 CFR Parts 61 and 63, National Emission Standards for Hazardous Air Pollutants) as described in paragraph (f) of the definition of "Major Source of Air Pollution" or "Title V Source" as set forth in Rule 62-210.200, Florida Administrative Code (F.A.C.).

2. Previously Submitted Information

All renewal applications are required to be treated the same as an initial application for purposes of identifying and certifying compliance with all applicable requirements. For renewal applications, it is not acceptable to reference previously submitted information. To be a complete application, all information must be reviewed, updated, submitted and certified as to its accuracy. The following information is a sample of missing information from this renewal application that must be submitted. You should thoroughly review the application to ensure that all of the information necessary to validate the professional engineer's and the responsible official's certifications is included.

In Section C. Facility Additional Information, Page 15:

- a. Facility Plot Plan: A facility plot plan is required for all Title V permit renewals. Please provide a plot plan of the facility showing the location of existing and proposed manufacturing processes, control equipment, stacks, vents, identifiable sources of fugitive emissions and principal buildings.

- b. Process Flow Diagram(s): A process flow diagram is required for all Title V permit renewals. Please provide a general process flow diagram or set of diagrams showing any proposed new or modified emissions units and all existing emissions units at the facility. Indicate the operating rate of each emissions unit, and identify the pathways by which raw materials and products flow from unit to unit.
- c. Precautions to Prevent Emissions of Unconfined Particulate Matter: A description of precautions to prevent emissions of unconfined particulate matter is required for all Title V permit renewals. Please identify any unconfined particulate matter emissions that may result from construction, modification or operation of the facility, and describe the precautions that will be taken to prevent or control such emissions. For purposes of this requirement, it is not necessary to quantify such emissions. Examples of reasonable precautions to control unconfined emissions of particulate matter are listed at Rule 62-296.320(4), F.A.C.


In Appendix D attachment - Suggested Revisions to Existing Title V Permit:

3. RICE emissions Units: Please provide the total hours of operation per year for each RICE emission unit. Also, specify how the facility is complying with the applicable subpart(s) and rules applicability for each emission unit. Please link to www.dep.state.fl.us/air/emission/engine_pump_tools.htm for engine applicability assistance.
4. Annual performance test for hydrogen chloride (HCl) and fugitive ash: The applicant requests a modification to the annual performance test for HCl and for fugitive ash. The current permit matches the language in 40 CFR 60, subparts Cb, and requires testing every 12 months. The applicant requests to change this test frequency to every 9 to 15 months, with five testes minimum for every 5 calendar years period. Please provide the rationale for making this change.
5. Monitoring requirement for fluoride: PSD-FL-127 Specific Condition 3.g and Title V specific condition A.23 states the emission limit for fluoride compounds. The applicant requests that this condition be removed from both PSD and Title V Permit. Please provide the historical stack test data indicating that fluoride is emitted at a rate that is less than the applicable PSD significant emissions threshold.
6. Monitoring requirements for volatile organic compounds (VOC): PSD-FL-127 Specific Condition 3.e states the emission limit for VOC. The applicant requests that this condition be removed from both PSD and Title V Permit. Please provide the historical stack test data indicating that VOC is emitted at a rate that is less than the applicable PSD significant emissions threshold.

The Department will resume processing your application after receipt of the requested information. Rule 62-4.050(3), F.A.C., requires that all applications for a construction permit must be certified by a professional engineer registered in the State of Florida. This requirement also applies to responses to Department requests for additional information of an engineering nature. For any material changes to the application, please include a new certification statement by the authorized representative or responsible official. Rule 62-4.055(1), F.A.C., also requires applicants to respond to requests for information within 90 days or provide a written request for an additional period of time to submit the information.
