Dear Mr. Packer:

The facility's initial Title V Permit was issued October, 2002, and effective on January 1, 2003. During review of the annual emissions fee form submission for calendar year 2002, it was discovered that certain applicable requirements related to volatile organic compounds (VOC) emissions were inadvertently omitted from the FINAL Title V Permit for the facility. The missing requirements are contained in Specific Conditions Nos. 18. and 21. of SIP Air Construction Permit No. 1010373-001-AC (PSD-FL-280). Since these missing applicable requirements are applicable to your facility, the Department is required to open your Title V Permit for cause and install these missing requirements in accordance with Rules 62-4.080(1), 62-213.430(4) and 62-213.440(1), F.A.C., and 40 CFR 70.7(f)(1)(iii).

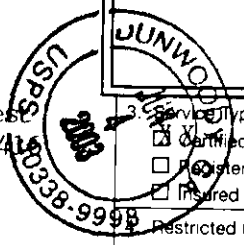
