I, Timothy Mahoney, President and CEO of Honeywell Aerospace, an operating unit of Honeywell International Inc. (the "Corporation"), pursuant to the authority sub-delegated to my position by David M. Cote, Chief Executive Officer, on 9/26/09, do hereby sub-delegate to the individuals occupying the positions of Vice President of Integrated Supply Chain, Vice President of OEM Manufacturing, Vice President of Aftermarket Services and Product Center Vice Presidents:
