Dear Ms. DeVore:

On September 28, 2008, Lakeland Electric received the above referenced construction permit to make improvements to its C.D. McIntosh, Jr. Power Plant's coal handling and transfer system. On June 17, 2009 Lakeland Electric submitted a request to amend this construction permit and received a Request for Additional Information from the Department on July 16, 2009 requesting a revised application with supporting documents. Presently, Lakeland Electric's engineering department is considering other minor alterations to the design of this coal handling and transfer system in order to meet Lakeland Electric's coal yard conveying and mixing needs. Therefore, Lakeland Electric requests postponement of its revised application submittal until a determination is made by Lakeland Electric engineers on the final design of the coal yard conveyor system. This request will alleviate the Department from the possibility of performing multiple revisions to the same permit.

However, at this time Lakeland Electric still requests that the expiration date of the construction permit be extended to December 31, 2011, as initial construction of the proposed project has been delayed.
