Tampa Electric Company (TEC) has received your letter of incompleteness dated February 10, 2004 addressing the proposed request of some minor items in the current Polk Power Station (PPS) Title V Air Operation permit TEC believes can be improved through minor revisions and clarifications. For the most part, these requested modifications involve procedural issues, and do not affect the nature and character of the emissions from this facility. Since several of the requested changes will require amendments to the previously issued Air Construction permit No. PSD-FL-194, TEC is re-submitting the Title V Air Operation Permit Revision application to simultaneously process the air construction permit with the Title V Air Operation Permit Revision, incorporating the proposed project. 
