The purpose of this project is to revise the existing Title V permit to incorporate Permit No. 0570373-020-AC, which authorized the installation of oxidation catalysts on four existing diesel fired generators. The generators are non-emergency generators and are subject to 40 CFR 63 Subpart ZZZZ, National Emissions Standards for Hazardous Air Pollutants (NESHAP) for Stationary Reciprocating Internal Combustion Engines (RICE). This facility is located at 2700 Maritime Boulevard, Tampa, Hillsborough County; UTM Coordinates: Zone 17, 364.00 East and 3089.5 North; Latitude: 27° 55' 20" North and Longitude: 82° 26' 20" West.

The Title V air operation permit is issued under the provisions of Chapter 403, Florida Statutes (F.S.), and Florida Administrative Code (F.A.C.) Chapters 62-4, 62-210, 62-213. The above named permittee is hereby authorized to operate the facility in accordance with the terms and conditions of this permit.
