

Section I. Facility Information.

Subsection A. Facility Description.

This facility consists of a municipal solid waste disposal facility (landfill). Although the landfill has had Tier 2 testing conducted that demonstrates that an active gas collection and control system is **not** currently required under 40 CFR 60, Subpart WWW, the county voluntarily constructed an active gas collection system on completed portions of the Class I landfill including the top and the side slopes (excluding the eastern slope) of Segment 1 and the southern and the eastern slopes of Segment 2. The active collection system terminates with a blower followed by a flare. This construction was permitted through the Department's Central District Solid and Hazardous Waste Program (permit number SO31-0128769-004 as modified by SO31-0128769-005).

Also included in this permit are miscellaneous insignificant emissions units and/or activities.

Based on the Title V Air Operation Permit Renewal application received December 27, 2006, this facility is **not** a major source of hazardous air pollutants (HAPs).

Section II. Facility-wide Conditions.

The following conditions apply facility-wide:

1. APPENDIX TV-6, TITLE V CONDITIONS are a part of this permit.
2. General Pollutant Emission Limiting Standards. Objectionable Odor Prohibited. The permittee shall not cause, suffer, allow, or permit the discharge of air pollutants which cause or contribute to an objectionable odor.
[Rule 62-296.320(2), F.A.C.]
3. General Particulate Emission Limiting Standards. General Visible Emissions Standard. Except for emissions units that are subject to a particulate matter or opacity limit set forth or established by rule and reflected by conditions in this permit, no person shall cause, let, permit, suffer or allow to be discharged into the atmosphere the emissions of air pollutants from any activity, the density of which is equal to or greater than that designated as Number 1 on the Ringelmann Chart (20 percent opacity).
[Rule 62-296.320(4)(b)1., F.A.C.]
4. Prevention of Accidental Releases (Section 112(r) of CAA).
 - a. The permittee shall submit its Risk Management Plan (RMP) to the Chemical Emergency Preparedness and Prevention Office (CEPPO) RMP Reporting Center when, and if, such requirement becomes applicable. Any Risk Management Plans, original submittals, revisions or updates to submittals, should be sent to:

 - b. The permittee shall submit to the permitting authority Title V certification forms or a compliance schedule in accordance with Rule 62-213.440(2), F.A.C.

5. Insignificant Emissions Units and/or Activities. Appendix I-1, List of Insignificant Emissions Units and/or Activities, is a part of this permit.
[Rules 62-213.440(1), 62-213.430(6), and 62-4.040(1)(b), F.A.C.]
6. General Pollutant Emission Limiting Standards. Volatile Organic Compounds (VOC) Emissions or Organic Solvents (OS) Emissions. The permittee shall allow no person to store, pump, handle, process, load, unload or use in any process or installation, VOC or OS without applying known and existing vapor emission control devices or systems deemed necessary and

ordered by the Department. To comply, procedures to minimize pollutant emissions shall include the following:

- a. Tightly cover or close all VOC containers when they are not in use;
- b. Tightly cover, where possible, all open troughs, basins, baths, tanks, etc.;
- c. Maintain all piping, valves, fittings, etc. in good operating condition;
- d. Prevent excessive air turbulence across exposed VOC; and
- e. Immediately confine and clean up spills of VOC containing materials.

[Rule 62-296.320(1)(a), F.A.C.]

7. Emissions of Unconfined Particulate Matter. Reasonable precautions to prevent emissions of unconfined particulate matter at this facility include:

- a. Chemical or water application to unpaved roads and unpaved yard areas;
- b. Paving and maintenance of roads, parking areas and yards;
- c. Landscaping or planting of vegetation; and
- d. Other techniques, as necessary.

[Rule 62-296.320(4)(c)2., F.A.C.]

8. When appropriate, any recordings, monitoring, or reporting requirements that are time-specific shall be in accordance with the effective date of the permit, which defines day one.

11. Annual Statement of Compliance. The annual statement of compliance pursuant to Rule 62-213.440(3)(a)2., F.A.C., shall be submitted to the air compliance section of this office and EPA within 60 (sixty) days after the end of the calendar year using DEP Form No. 62-213.900(7), F.A.C.

12. Certification by Responsible Official (RO). In addition to the professional engineering certification required for applications by Rule 62-4.050(3), F.A.C., any application form, report, compliance statement, compliance plan and compliance schedule submitted pursuant to Chapter 62-213, F.A.C., shall contain a certification signed by a responsible official that, based on information and belief formed after reasonable inquiry, the statements and information in the document are true, accurate, and complete. Any responsible official who fails to submit any required information or who has submitted incorrect information shall, upon becoming aware of such failure or incorrect submittal, promptly submit such supplementary information or correct information. [Rule 62.213.420(4), F.A.C.]

13. Annual Operating Report. A DEP Form No. 62-210.900(5), "Annual Operating Report for Air Pollutant Emitting Facility" including the Emissions Report, shall be completed for each calendar year **on or before March 1** of the following year and submitted to the air compliance section of this office.

14. At least 180 days prior to the expiration date of this operation permit, the permittee shall submit to this office four copies of the air permit application, DEP Form No. 62-210.900(1).

{Permitting note: This emissions unit is regulated under: NSPS - 40 CFR 60, Subpart WWW, Standards of Performance for Municipal Solid Waste Landfills, adopted and incorporated by reference in Rule 62-204.800, F.A.C. Tier 2 testing results submitted in January 2007, demonstrate that the landfill is below the threshold for control requirements of 50 Megagrams per year NMOC in 40 CFR 60.752(b)(1)(ii)(A); therefore, the landfill is currently subject only the emissions rate reporting requirements of 40 CFR 60.752(b)(1)(i), 40 CFR 60.757(b) and 40 CFR 757(c) and the recordkeeping requirements of 40 CFR 60.758(a). The requirements summarized in Tables 1 and 2 do not currently apply to the landfill, and only the **bold section** of Table 3 currently applies}

The following specific conditions apply to the emissions unit(s) listed above:

Essential Potential to Emit (PTE) Parameters

A1. Hours of Operation. This emissions unit is allowed to operate continuously, i.e., 8,760 hours per year.

Emission Limitations and Standards

A2. No person shall cause, let, permit, suffer or allow to be discharged into the atmosphere the emissions of air pollutants from any activity, the density of which is equal to or greater than that designated as Number 1 on the Ringelmann Chart (20 percent opacity).
[Rule 62-296.320(4)(b)1., F.A.C.]

Test Methods and Procedures

{Permitting note: Table 2-3, Summary of Compliance Requirements for Municipal Solid Waste Landfills, summarizes information for convenience purposes only. This table does not supersede any of the terms or conditions of this permit.}

A3. The flare must be tested for visible emissions in accordance with EPA Method 9. The test shall last 30 minutes. Initial testing shall be conducted within 180 days of initial startup. Subsequent testing shall be conducted annually.
[Rules 62-4.070 and 62-297.310(4)(a)2., F.A.C.]

A4. The permittee shall notify the Central District Office of the DEP, in writing, at least 15 days prior to the date on which the formal compliance test is to begin. The notification shall include the date, time and place of each such test, as well as the name of the contact person who will be responsible for coordinating and having such tests conducted for the owner.
[Rule 62-297.310(7)(a)9., F.A.C.]

A5. The type of fuel and the heat input to this source must be entered on the visible emission test report.

A6. The required test report shall be filed with the Department as soon as practical but no later than 45 days after the last sampling run of each test is completed.
