Dear Mr. Frost:

The above referenced Draft Air Construction Permit and DRAFT/PROPOSED Title V Air Operation Permit Revision issued on January 25, 2013 are withdrawn. Enclosed is the modified draft/proposed permit package and the modified draft air construction permit package for the Palatka Mill site. This facility is located at 215 County Road 216 in Putnam County, Palatka, FL. The permit package includes the following documents:

- The Statement of Basis, which summarizes the facility, the equipment, and the primary rule applicability, and the changes since the last Title V renewal.
- The Technical Evaluation and Preliminary Determination, which summarizes the the draft/proposed Title V air operation permit revision and the draft air construction permit, which includes the specific permit conditions that regulate the emissions units covered by the proposed project.
- The Written Notice of Intent to Issue Air Permit provides important information regarding: the Permitting Authority's intent to issue an air permit for the proposed project; the requirements for publishing a Public Notice of the Permitting Authority's intent to issue an air permit; the procedures for submitting comments on the draft/proposed permit and the air construction permit; the process for filing a petition for an administrative hearing; and the availability of mediation.
- The Public Notice of Intent to Issue Air Permit is the actual notice that you must have published in the legal advertisement section of a newspaper of general circulation in the area affected by this project. The Public Notice of Intent to Issue Air Permit must be published as soon as possible and the proof of publication must be provided to the Department within seven days of the date of publication. **Facility Location:** The applicant (Georgia-Pacific Consumer Operations LLC) operates the Palatka Mill located at Putnam County, North of County Road 216 and West of U.S. Highway 17 in Palatka, Florida.

**Project:** The applicant applied on November 5, 2012 for a Title V Air Operation Permit Revision. This is a revision of Title V Air Operation Permit No. 1070005-068-AV. This facility is a Kraft pulp and paper mill that consists of major activities areas such as: chip handling, pulping, bleaching, chemical recovery, utilities, paper machines, converting, turpentine and tall oil production. The purpose of Title V Air Operation Permit Revision No.: 1070005-076-AV is to revise the Title V Air Operation Permit No. 1070005-068-AV to incorporate the terms and conditions of Permit No. 1070005-072-AC and to make minor changes to the No. 4 Recovery Boiler fuel oil burner descriptions, deletion of the steam capacity comments for the No. 4 Recovery Boiler, and to delete references to the burning of ultra low sulfur distillate fuel oil in the No. 4 Recovery boiler since the equipment utilized to burn ULSD fuel oil has been removed.

On December 21, 2012 the applicant clarified that the original application (received November 5, 2012) was also for an air construction permit [No.: 1070005-079-AC (to be concurrently processed)] to modify certain terms and conditions of air construction permit No.: 1070005-050-AC regarding fuel oil burner capacities (as installed) and the steam capacity description. The original Intent to Issue Permit was issued on January 25, 2013. Comments were received from the applicant and the permits were modified; therefore those documents are withdrawn effective the issue date of the modified Intent to Issue Permit the draft/proposed Title V air operation permit revision and a draft air construction permit.

**Permitting Authority:** Applications for Title V air operation permits are subject to review in accordance with the provisions of Chapter 403, Florida Statutes (F.S.) and Chapters 62-4, 62-210, 62-213 of the Florida Administrative Code (F.A.C.). - (d) A statement of all disputed issues of material fact. If there are none, the petition must so state;
- (e) A concise statement of the ultimate facts alleged, as well as the rules and statutes which entitle petitioner to relief;
- (f) A statement of the specific rules or statutes the petitioner contends require reversal or modification of the agency's proposed action; and,
- (g) A statement of the relief sought by the petitioner, stating precisely the action petitioner wishes the agency to take with respect to the agency's proposed action.

A petition that does not dispute the material facts upon which the permitting authority's action is based shall state that no such facts are in dispute and otherwise shall contain the same information as set forth above, as required by Rule 28-106.301, F.A.C.

Because the administrative hearing process is designed to formulate final agency action, the filing of a petition means that the permitting authority's final action may be different from the position taken by it in this notice of intent. Persons whose substantial interests will be affected by any such final decision of the permitting authority on the application(s) have the right to petition to become a party to the proceeding, in accordance with the requirements set forth above.

Mediation is not available for this proceeding.

Any petition shall be based only on objections to the Permit that were raised with reasonable specificity during the 30-day public comment period provided in the Public Notice, unless the petitioner demonstrates to the Administrator of the EPA that it was impracticable to raise such objections within the comment period or unless the grounds for such objection arose after the comment period. Filing of a petition with the Administrator of the EPA does not stay the effective date of any permit properly issued pursuant to the provisions of Chapter 62-213, F.A.C. Petitions filed with the Administrator of EPA must meet the requirements of 42 U.S.C. Section 7661d(b)(2) and must be filed with the Administrator of the EPA at: U.S. EPA, 401 M Street, SW, Washington, D.C. 20460.
