Pursuant to Section 403.0872(6), Florida Statutes, if no objection to the proposed Title V air operation permit is made by the USEPA within 45 days, the proposed permit will become a final permit no later than 55 days after the date on which the proposed permit was mailed (posted) to USEPA. If USEPA has an objection to the proposed permit, the final permit will not be issued until the permitting authority receives written notice that the objection is resolved or withdrawn.

## PROPOSED PERMIT DETERMINATION

Permit No. 1210468-002-YYY -AV

### I. Public Notice.

An Intent to Issue Air Permit issued to Klausner Holding USA Inc. for the Suwannee Mill located in Suwannee County at 17152 46<sup>th</sup> Trace, Live Oak, Florida, was clerked on January 20, 2017. The Public Notice of Intent to Issue Air Permit was published in Suwannee Democrat on February 8, 2017. The draft Title V air operation permit was available for public inspection at the permitting authority's office in Tallahassee. Proof of publication of the Public Notice of Intent to Issue Air Permit was received on February 10, 2017.

### II. Public Comment(s).

No Comments were received from the public during the 30-day public comment period; however, comments were received from the Permittee. The comments were not considered significant enough to reissue the draft Title V air operation permit and require another Public Notice; therefore, the draft Title V air operation permit was changed. Those comments are addressed below. Additions to the permit are **highlighted** in yellow with additions in **double underline** text and deletions in **strikethrough** text.

#### Email from Michael Ballenger dated February 21, 2017.

**Comment 1.** Please correct the emission units (EU) description table in Section I.B (page 2 of 25) to reflect that for EU 009 (Sorter Line and Trimmers) one dry sorter line, one planner line and one trimmer line in the sorter are not yet constructed. In addition, please move the green lumber sorting line to EU 011 and indicate that it has not yet been constructed. Finally, for EU 008 (Two Planer Mill Lines with Two Dry Shaving Silos, please indicate that one of the silos have yet to be constructed.

**Response 1.** The Department agrees with the comment and the emission unit description table is changed as follows:

012	Five Emergency Generators ( <b>four generators not yet constructed</b> )

**Comment 2.** In Section III.B (page 9 of 25), Specific Condition B.4 "Permitted Capacity", please change "maximum allowable heat input rate" to "design heat input rate" to accurately reflect the language in the original air construction permit (No. 1210468-001-AC, PSD-FL-417).

**Response 2.** This change will be made to reflect the language of the original air construction permit as follows:

**B.4. Permitted Capacity.** The **maximum allowable design** heat input rate is as follows:

**Comment 3.** Please replace the old version of the Boiler Startup, Shutdown, and Maintenance Procedures with the newer version.

**Response 3.** The Appendix Boiler, Startup, Shutdown and Maintenance Procedures was replaced with the newer version.

**Comment 4.** Please remove the incorrect references in Section III.H (page 25 of 25), Specific Condition H.1 pertaining to NSPS Subpart Kb. Also, please add a permitting note that once the tanks are designed and constructed they will be removed from Section II.H and placed in Appendix I dealing with insignificant activities.

**Response 4.** These tanks are not subject to NSPS Subpart Kb and consequently the references will be removed as shown below. Also, the permitting note shown below will be added to the section.

### Equipment

#### **H.1. Storage tanks:**

- The permittee is authorized to operate and maintain 16,000 gallon or less Diesel Storage Tank with a fixed roof to minimize VOC emissions ~~as per 40 CFR 60.110b(a)(2).~~
- The permittee is authorized to operate and maintain two 10,000 gallon or less Diesel Storage Tanks, each with a fixed roof to minimize VOC emissions ~~as per 40 CFR 60.110b(a)(2).~~
- The permittee is authorized to operate and maintain three 265 gallon or less Diesel Storage Tanks with a fixed roof to minimize VOC emissions ~~as per 40 CFR 60.110b(a)(2).~~
- The permittee is authorized to operate and maintain 10,000 gallon or less of reductant storage ~~in accordance with 40 CFR 60.130.~~ The storage of reductant that is used for NOx control in the SNCR system, shall comply with all applicable requirements of the Chemical Accident Prevention Provisions in 40 CFR 68.
- The permittee is authorized to operate and maintain a 26,400 gallon or less mold/stain protection storage tank to preserve the finished lumber.

*(Permitting Note: Once design and construction of the tanks are finalized, the tanks shall be moved from Section III.H and placed in Appendix I for insignificant activities.)*

**Comment 5.** Please update the Best Management Practices in Appendix BMP, Best Management Practices to reflect recent changes.

**Response 3.** Appendix BMP, Best Management Practices was updated to reflect the changes.

### **III. Conclusion.**

The enclosed proposed Title V air operation permit includes the aforementioned changes to the draft Title V air operation permit.

The permitting authority will issue the proposed permit No. 01210468-002-AV, with the changes noted above.
