**COMMENTS:** This facility consists of two separate 'plants'. Plant #1 includes one cement silo and a ground-level baghouse. Plant #2 includes a fly ash silo with a ground-level baghouse and a cement silo with a ground-level baghouse. For each plant, a spray bar system is established to control emissions at the truck loading rack.

No concrete batching occurred at the time of the inspection. According to facility personnel, most of the batching was being performed early in the morning as part of a large hospital project. The facility appears to be maintained appropriately. There was a significant amount of wet ground late in the afternoon during the inspection, indicating that the facility was working hard to ensure fugitive emissions are minimized. The aggregate piles are contained in block areas and are actively wetted with a sprinkler system that was operating at the time of the inspection. Facility staff stated that the spray bar systems on the plants are working effectively and are maintained on a regular basis to prevent clogging of the nozzles. The facility was in compliance with permit conditions at the time of the inspection.

**Recommendations**

In accordance with permit requirements, and due to the proximity of the facility to the downtown area of Bonifay, it is recommended that the facility continue to actively ensure that fugitive emissions are prevented. This should include: removal of dust; removal of material buildup on the plant; and removal of loose aggregate from the yard.

Rule 62-210.310, revised January 2007, Paragraph (5)(b), no longer requires a facility to keep records for production or fuel usage unless co-located with another facility.
