COMMENTS: INS 3. Observed visible emissions compliance tests for EU 005 (NW baghouse on N silo); EU 007 (SW baghouse on S silo); EU 008 (weigh hopper baghouse). All tests were in compliance. Also, observed EU 003 (truck loadout); no visible emissions at the time of this inspection. Maximum psi = ~8 - 10. (Truck #1 & Truck #2 each started at 8 psi; 2/3 done were at 10 psi)
