Most of the aggregate piles were empty of material but there was some 57 rock, 89 rock, and sand onsite. The facility could operate any day if needed, but will be idle for the time being. If Seminole Precast opens the facility may commerce operations again. Jason Jones will be contacted for further information and to see if a Temporary Shutdown notice is needed. The office was locked and no records were able to be viewed.
