COMMENTS: Pre-inspection review: Emission Units (EU) 1, 3, and 4 were last tested in 09/2008. EU's 2 and 5 were last tested in 10/2008. Inspection Findings: Sprinklers were in operation upon my arrival at the site. Roadways and parking areas were relatively free of particulate. Testing will be conducted on this date at the Ready Mix Plant only. The Ready Mix plant has three emission units: Cement Silo, Flyash Silo, and Weigh Hopper Dust Collector. Mr. James Williams is in charge of the Ready Mix Plant and Mr. Casey Jones is in charge of the Block Plant. I attempted to conduct and inspection at the Block Plant, but no one was there. According to Mr. Williams, the Block Plant is only operating about once a month and only one line is operating right now. Emission Units 1 and 2 were successfully tested above 25 TPH on this day. The weigh hopper on the Ready Mix plant was tested on 09/15/2009. The facility tested Emission Units 4, and 5 on 09/15/2009. Reports for testing conducted on this day were timely submitted to the Department on August 7, 2009.
