COMMENTS: ON JULY 14, 2008 AT 1:26 P.M., I VISITED THIS FACILITY TO WITNESS A VISIBLE EMISSIONS TEST ON THE CONCRETE READY MIX PLANT. THIS WAS A RETEST. THE PLANT FAILED THE VE TEST TWICE BEFORE. RYAN PETERSON PERFORMED THE THIRTY (30) MINUTES VE TEST ON THE CENTRAL DUST COLLECTOR. THE SILO WAS LOADED AT 12 PSI. I DID NOT OBSERVE ANY VISIBLE EMISSIONS DURING THE TEST.
