COMMENTS: ON APRIL 21, 2009 AT 1:00 PM., I VISITED THIS FACILITY TO CONDUCT A COMPLIANCE INSPECTION AND TO WITNESS A VISIBLE EMISSIONS TEST ON THE CONCRETE READY MIX AND CONCRETE BLOCK PLANTS.
RYAN PETERSON OF ARLINGTON ENVIRONMENTAL SERVICES CONDUCTED THIRTY (30) MINUTES VE TESTS ON THE CENTRAL DUST COLLECTOR SERVING THE SPLIT SILO AND THE WEIGH HOPPER OF THE READY MIX PLANT AND THE CEMENT SILO OF THE CONCRETE BLOCK PLANT. THE FLYASH SILO WAS FULL AND WILL BE TESTED AT A LATER DATE.
THE SILOS WERE LOADED WITH CEMENT AT 10 PSI.
I DID NOT OBSERVE ANY VISIBLE EMISSIONS WHILE I WAS ON SITE.
I DID NOT OBSERVE ANY FUGITIVE PARTICULATES AROUND THE FACILITY. THE WHOLE YARD IS PAVED AND KEPT WET.
