COMMENTS: On June 03, 2010 I visited this facility to conduct a compliance inspection and to witness a visible emissions test on the concrete ready mix plants. On site I met Mr. Michael Blanco, the plant operations manager. The Concrete Block Plant of this facility was closed. The concrete production of this facility is approximately 4000 yards per month. Bill Arlington of Arlington Environmental Services conducted the visible emission tests on the central dust collector serving the split silo and the weigh hopper of the ready mix plant. The silos were loaded with cement at 12 PSI and flyash at 13 PSI. No visible emissions were observed during my visit. I did not observe any fugitive particulates around the facility and the water truck kept the whole yard wet.
