COMMENTS: ON NOVEMBER 26, 2007 I VISITED THIS FACILITY TO CONDUCT THE ANNUAL COMPLIANCE INSPECTION. ON SITE I MET LUIS SALGADO, THE PLANT MANAGER. THE PLANT PRODUCES ABOUT 100 YARDS OF CONCRETE A DAY. MAINTENANCE WAS DONE ON THE BAG HOUSE 3 MONTHS AGO. THE FACILITY HAS GOOD HOUSE KEEPING WITH A WATER TRUCK KEEPING THE ROADS WET WHE NEVER THE PLANT IS OPERATING. THERE WERE NO FUGITIVE EMISSIONS SEEN AT THE SILOS OR BAG HOUSE AREAS.
