COMMENTS: Observed annual compliance test and conducted site inspection. VE on the Baghouse Exhaust was 0% opacity. Housekeeping issues need to be addressed. The paved areas were adequately wetted but excessive amounts of mud on these paved areas were noted. The stock pile area (back yard) was extremely dusty and had not been watered for several days (2+). When asked about a water truck, the operators responded that they did not have one. When advised that the stock pile area was extremely dusty and that it needed to be watered I was advised that they didn't have a way to do it. Contacted Terry Lancaster and advised her of my observations and that corrective actions needed to be taken prior to my departure to avoid enforcement and penalties. Visible emissions associated with the tanker truck were observed leaving the property.

Following the call, Mr. Dan Whitman (772-201-5121) was contacted and advised of the problem. The facility filled a batch truck with water and watered the area prior to departure.
