COMMENTS: SG and DG witnessed the annual VE tests for the Rinker E. Fort Pierce concrete batch plant that were performed by Beatty Environmental Services (BES) using Method 9. BES performed 30-minute VE tests for the cement silo's western compartment as well as the weigh hopper/truck loadout. DG performed 12-minute VE tests for these emission units which both had 0 % opacity. The cement silo's eastern compartment (for flyash) was not tested during this inspection. Emissions from the cement silo's western and eastern compartments were controlled by separate baghouses. Emissions from the weigh hopper/truck loadout were controlled by a central dust collector.

No fugitive dust emissions were detected leaving the property. Paved areas were cleaned twice a week by a contracted mechanical sweeper. The facility conducted quarterly environmental/safety inspections. The facility kept receipts for deliveries of low-sulfur on-road diesel fuel that was stored in a 12,000-gal. AST. The facility stored sand and aggregate in silos and had covered conveyors.
