**INSPECTION COMMENTS:**

The inspector arrived on-site and met with Frank Carey, Operations Specialist. The inspector then observed the facility operation.

A cement supply truck was on-site and hooked up to one of the silos. Emissions from the silo appeared to be under 5% opacity.

There were no batch trucks being loaded at the drop point during the inspection.

Mr. Carey explained that all "brand new" emission control equipment had been installed. The inspector observed an operational drop point baghouse, as well as three separate silo filter units.

The inspector reviewed the DEP database and noted that the last visual emission review by the Department was performed on September 21, 2006. The report review had a status of in-compliance.

**RECOMMENDATIONS:**

The facility appears to be in-compliance. No recommendations at this time.
