COMMENTS: The inspector, Ilka Bundy, met with Sig Bo, Regional Environmental Manager for East Central Florida to conduct an visible emission audit for the concrete batch plant. The cement loading rate was 32.6 tph and the opacity was zero percent. The flyash loading rate was 36.2 tph and the opacity was also zero percent. The truck load-outs had an opacity of zero percent. According to Sig Bo, EU002 will be replaced with a newer unit in the near future. The silo is onsite, but has not been installed. Sig Bo will apply for a new permit in the near future. Two new yard sweepers were recently purchased. One sweeper is for the Orlando facilities while the other sweeper is for the Brevard County facilities.
