COMMENTS: In a compliance inspection that was conducted on 10/8/2009 AQD staff observed operations at Imperial Cleaners. Mr. Marlon Thompson accompanied AQD staff on the inspection. Mr. Thompson is not keeping very good records of PERC purchases, temperature cooldown or leak checks. The DEP calendar was posted, but not utilized. Mr. Thompson will be receiving a WN for improper record keeping.

Multiple Haz-mat issues were noted so a request for Nick Kontax (PPRAQD-ERD) to accompany on another inspection was initiated.

On 11/3/2009, E. Susky and N. Kontax conducted a compliance inspection of Imperial Cleaners. The facility has very bad work practices and inadequate secondary containment. A WN will multiple counts will be issued addressing this issues for the hazardous materials section.
