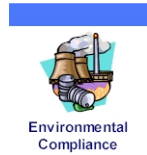

COMMENTS: EU001 East of storage bin has a Butler Model DF-44 baghouse. EU002 has a Butler Model DF-44 baghouse and is located West of the storage silo. A wet, slurry mix is loaded into trucks. The slurry is used to make pretress products. Tall silos are used to store aggregate. The facility has a water truck, which is shared with Central Hauling & Excavating. Coreslab rents out part of their property to Central Hauling & Excavating. Records for diesel fuel usage is kept by both facilities. 24,000 gallons per year of fuel oil is used by Coreslab. Records for material processed and fuel oil sulfur content is also kept. The facility uses Ultra Low Sulfur diesel. The consultant present was Kenneth Given from Air Testing & Consulting. Coreslab missed their 2007 annual compliance testing. The observed opacity was zero percent. The loading rate for both silos was 25.8 tph.
