**COMMENTS:** The annual visible emissions (VE) inspection was conducted at Coreslab Structures (Orlando). Inspector, Norma Ali, met with Chuck Preyer, Maintenance and Kenneth Given from Air Testing & Consulting, Inc., facility's consultant. Visible emissions audits were conducted on two (2) silos.

**Truckload:**

Truck #1 Cement – 26.65 tons Split load into the two silos (~30 min. for each silo)

**Loading rate:**

1. Cement silo (01) loading rate = ~26.65 tph at 10 PSI.
  2. Cement storage Bin (02) loading rate = ~ 26.65 tph at 10 PSI.
- The loading rate is over the minimum requirement of 25 tph.

Roads are paved/swept regularly.

Storage bins contain aggregate.

Roads were dry. No PM was observed leaving the property.
