COMMENTS: The annual visible emissions (VE) inspection was conducted on Paver System's two cement silos. Grey cement was contained in the west silo and was filled at the normal filling rate; 26.2 Tons were loaded during the 30 minute test. White cement was in the east silo and it was loaded at 25.4 Tons in the 30 minute test. No fugitives emissions observed, no objectional odors detected. Sara Hummel of Grove Scientific, consultant, performed the test for the facility. Monthly process material records were being kept by computer along with records of the monthly purchase of diesel fuel. Low sulfur diesel was used only and analysis records were received for each shipment.
