COMMENTS: On June 15, 2010, Ms. Danielle Owens of FDEP conducted a Level 2 compliance inspection at the subject facility. The following potential non-compliance items were discovered during the inspection: 1) Manifest were not available for review at time of the inspection. 2) Floor surrounding perc machine and hazardous waste storage area needs re-sealing. Corrective Actions taken: 1) Facility submitted manifest to the Department on June 23, 2010. The Responsible Official was not available during the inspection. The Annual Compliance Certification Form was left with at the facility and instruction were given for the form to be completed and submitted the Department. Completed form was received on June 23, 2010. The entitlement for this facility expires Novemeber 11, 2010. Facility was given a Perchloroethylene Dry Cleaner Air General Permit Notification and was instructed to submit the completed form at least 30-days prior to the expiration date.
