**COMMENTS:** ON MARCH 27, 2008 I VISITED THIS FACILITY TO WITNESS A VISIBLE EMISSIONS TEST AND TO CONDUCT THE ANNUAL COMPLIANCE INSPECTION. ON SITE I MET ANTONIO MAZPULE, THE FACILITY'S ENVIRONMENTAL CONSULTANT, ERNESTO ROSA, THE PLANT MANAGER AND RYAN PETERSON, THE VISIBLE EMISSIONS OBSERVER FROM ARLINGTON ENVIRONMENTAL SERVICES. THIS FACILITY HAS FIVE (5) EMISSIONS POINTS. THERE ARE THREE (3) SILOS, EACH WITH A DUST COLLECTOR AND TWO (2) WEIGH HOPPERS DUST COLLECTORS. ALL THESE EMISSIONS POINTS WERE TESTED FOR THIRTY (30) MINUTES EACH. THE SILOS WERE LOADED AT MORE THAN 25 TONS PER HOUR AND 10-12 PSI. I DID NOT OBSERVE ANY VISIBLE EMISSIONS DURING THE TESTS. THE WEIGH HOPPER'S DUST COLLECTORS WERE TESTED WHILE CONCRETE TRUCKS WERE LOADED WITH CONCRETE. I DID NOT OBSERVE ANY FUGITIVE PARTICULATES AROUND THE FACILITY.
