I met with Matt Carcaba, who is the operations manager at this Florida Rock Industries concrete batch plant. This plant was not operating during this inspection. Mr. Carcaba told me that their final load left at 10am this morning. I did a walk through with Mr. Carcaba and asked him several questions about the facility. The baghouse and silo was in good condition, all the stock piles had sprinklers on them and their grounds were clean. This facility appears to be in compliance.
