**COMMENTS:** Facility has two machines. Both were in the cool down mode at inspection. No. 1 reached a low of 39 deg F and No. 2, 19 deg F. The Department will mail the annual compliance certification to Mr. Browne at his business address in Marietta, GA. Mr. Disidoro is aware of the new EPA regulations. He is already looking for a halogen leak detector to be used for leak detection. By July 27, 2008, one must be used monthly to detect PERC leaks. During the inspection, I determined that each of the refrigerated condensers have pressure gauges. Part of the new requirements will be to record the pressure readings on a periodic basis. The Department's Small Business Environmental Assistance Program will be mailing each facility a fact sheet summarizing the ammendments.
