Mr. Haughey stated that this facility did utilize boat molds and conduct polyester resin work on-site. However, they now send that work to a contractor in the Daytona Area. AQD staff did observe boats being stored on-stie and minor paint and boat repairs being conducted. Mr. Haughey will be submitting polyester resin records to the department and still wanted to keep his permit active in case operations change.
