**COMMENTS:** In a compliance inspection conducted AQD staff (E. Susky and C. Bittle) observed operations at New River Boating Center. Mr. Rick De Freitas (manager) accompanied staff during the inspection and informed AQD staff that the New River Boating Center property had been sold (Passport Marine, Anderw Ginsberg-spoke to via phone later that day).

One large sailboat was observed to have work being conductee and AQD staff also observed boat molds on-site.

In a telephone conversation with AQD staff held later that day Mr. Ginsberg (new owner) stated that he planned on doing painting at the site and the boat molds were only being stored at the site. An application for the General Permit for surface coating was mailed to Mr. Ginsberg.

Facility permit for New River Boating Center will be deactivated.
