COMMENTS: On March 27, 2008, an unannounced compliance inspection was conducted at the Preferred Materials Inc. concrete batch facility. Emission units include a single compartment cement silo, a single compartment flyash silo, a cement weigh hopper and a concrete mixer truck loadout. The two silos are each equipped with cartridge dust collectors and the weigh hopper and truck loadout is equipped with a baghouse dust collector. Annual visible emission (VE) test are being conducted as required. The last VE tests were conducted on May 1, 2007 and June 19, 2007. During these test there were no visible emissions observed.

REMINDER: Vissible emission test must be conducted annually.

The facility roadway and yard are paved and weekly sweeping are being conducted. A water sprinkler system is used to keep aggregate piles wet to help batch concrete, which also helps to control dust. The overall facility appears to be well maintained and operating according to the permit description. No problems noted during the inspection.
