COMMENTS: Assefa Hailemariam and Mike Girton met with Barbra Rama and Joe Mendoza on August 30,2010. The inspectors conducted a walkthrough inspection and records audit. This facility does construction for entertainment, TV commercials and TV sets. We observed a working shop, one enclosed spray booth, one partially-enclosed spray booth, a metal shop, wood shop, and a fiberglass area. According to Ms. Rama, the operations are very slow. Mr. Joe Mendoza provided the records 2007 to present which showed the highest consecutive 12-month rolling total for resin gelcoat or combined HAPs was from August 2009 with 1.44925 tons, which is less than the permit limit of 38.0 tons. The facility was in good condition. No PM,leaks, spill were observed and no odors were detected.
