COMMENTS: Pre-inspection Review: Last Visible Emissions (VE) testing was conducted on May 23, 2008. Inspection Findings: VE testing was already underway on the Gunit Silo EU# 3 when I arrived at the facility. Sprinklers were also in operation upon my arrival. I witnessed the end of EU# 3 silo loading. I also witnessed the beginning of loading for EU #1--565 bbl cement silo. The facility's roadways were wet. Parking areas are paved. Mark Biro, plant manager, answered checklist questions. According to Mr. Biro, the facility began operating on May 9, 2007. Upon return to office, I noted that according to our ARM's database, the emission units at this facility were initially tested on June 4, 2007. Test reports were received on 06/01/2009. Photos were taken during my visit to this site and are attached to this report.
